Jual beli terdapat syari'at Islam menyangkut benda yang diperjual belikan. Tujuan penelitian untuk mengetahui hukum jual beli dalam Islam, implemetasi jual beli ayam Bangkok sebagai ayam petarung di Desa Cangkuang Kulon Kecamatan Dayeuhkolot Kabupaten Bandung, dan tinjauan hukum islam terhadap jual beli ayam Bangkok sebagai ayam petarung di Desa Cangkuang Kulon Kecamatan Dayeuhkolot Kabupaten Bandung.

Metode yang digunakan adalah kualitatif. Sumber data primer dari pihak penjual dan pembeli ayam. Data sekunder dari buku-buku, karya ilmiah al-Qur'an, Hadits. Teknik pengumpulan data ini adalah wawancara, Dokumentasi dan studi Pustaka.

Hasil penelitian ini bahwa hukum jual beli dalam Islam harus sesuai dengan rukun dan syarat yang telah ditetapkan. Implementasi jual beli ayam ialah para penjual maupun pembeli sangat selektif dalam memilih ayam Bangkok. Pandangan hukum Islam bahwa jual beli ayam tidak sesuai dengan syariat Islam karena objek yang diperjual belikan dimanfaatkan untuk di adu.

Buying and selling is Islamic syariat regarding objects that are traded. The research objectives were to determine the law of buying and selling in Islam, implementing the buying and selling of bangkok chickens as fighting chickens in cangkuang kulon village, dayeuhkolot district, and a review of islamic law on the sale and purchase of bangkok chickens as fighting chickens in cangkuang village, dayeuhkolot district, bandung regency.

The method used is qualitative. Primary data sources are chickens sellers and buyers. Secondary data from books, scientific works of al-Qur'an, hadits. These data collection techniques are interviews, documentation and literature study.

The result of this study indicate that the law of buying and selling in Islam must be in accordance with predetermined pillars and conditions. The implementation of buying and selling chickens is that sellers and buyers are very selective in choosing bangkok chickens. The view of Islamic law is that the buying and selling of chickens is not in accordance with Islamic law because the objects that are traded are used for fighting.
